1. The Government of India has received financing from the World Bank towards the cost of **Jhelum & Tawi Flood Recovery Project (JTFRP)** project and it is intended that part of the proceeds will be applied to eligible payments under the contract for which this 'Invitation for Bids' is issued.
2. The **Managing Director , Jammu Kashmir Industries Ltd.** now invites online bids from eligible bidders for ***Supply, Installation, Testing & Commissioning of Dyeing & Related Machinery for Government Woollen Mills, Bemina, Srinagar, J&K***
3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures agreed with World Bank. The bidding is open to all eligible bidders as defined in the Bank's Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 of the Guidelines setting forth the World Bank's policy on conflict of interest.
4. Bidding documents are available online on www.jktenders.gov.in for a non-refundable fee as indicated below, in the form of Demand Draft on any Scheduled/Nationalized bank payable at **Jammu** in favour of **Director Finance, JKI Ltd.** (Demand Draft to be submitted subsequently as per the procedure described in paragraph 7 below). Bidders will be required to register in the website, which is free of cost. The bidder would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated.

5. For submission of the bids, the bidder is required to have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities, authorised by Government of India for issuing DSC. Aspiring bidders who have not obtained the user ID and password for participating in e-procurement in this Project, may obtain the same from the website: www.jktenders.gov.in. A non-refundable fee of ₹1000/- (inclusive of taxes) is required to be paid (to be submitted along with other documents listed in paragraph 7 below) before the Opening of the Bid (Technical Part) i.e. before **25.02.2019**. The mode of payment shall be in the form of DD drawn in favour of **Director Finance JKI Ltd.** on any scheduled Bank payable at **Jammu**.
6. Bid security of the amount specified in the bidding document, drawn in favour of **Director Finance JKI Ltd.** must be submitted as per the procedure described in paragraph 7 below. The Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid. Bids must be submitted online on www.jktenders.gov.in on or before the date and time for receipt of bids, and the 'Technical Part' of bids will be opened online on the specified time and date for opening of bids, as given above. The "Financial Part" shall remain unopened in the e-procurement system until the second public bid opening for the financial part. Any bid or modifications to bid (including discount) received outside e-procurement system will not be considered. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time. The electronic bidding system would not allow any late submission of bids.
7. The bidders are required to submit (a) original demand drafts towards the cost of bid document; (b) original bid security in approved form; and (c) original affidavit regarding correctness of information furnished with bid document with the office of **Managing Director, Jammu Kashmir Industries Limited, Ground Floor, Jawaharlal Nehru Udyog Bhawan, Rail Head Complex, Jammu J&K-180012**, before opening of the technical part of the bid given above, either by registered post/speed post/courier or by hand, failing which the bids will be declared non-responsive and will not be opened.
8. Other details can be seen in the bidding document. The Purchaser shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the Purchaser shall not be liable for any information not received by the bidder. It is the bidders' responsibility to verify the website for the latest information related to this bid.
